INTRODUCTION

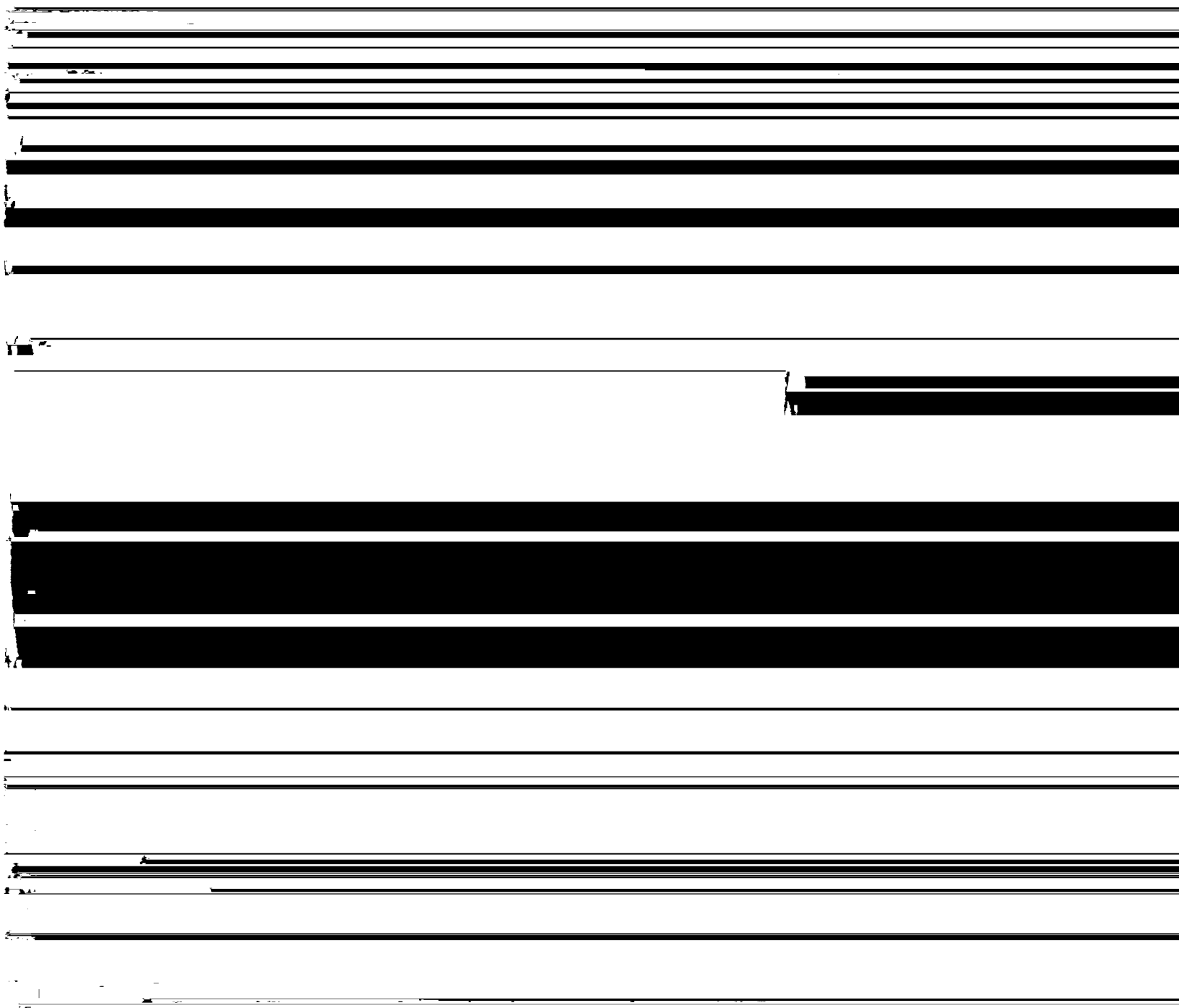

DISCUSSION

The All Writs Act provides that “[t]he Supreme Court and all courts established by Act of Congress may issue all writs necessary or appropriate in aid of their respective jurisdictions and agreeable to the usages and principles of law.” 28 U.S.C. § 1651(a). As

Apple, Google, Microsoft, Amazon, Facebook, and Twitter are all subject to the All Writs Act, the Court has jurisdiction to issue writs to these companies.



The government is aware, and can represent, that in other cases, courts have ordered Apple to assist in effectuating search warrants under the authority of the All Writs Act. Additionally, Apple has complied with such orders.

The requested order would enable agents to comply with this Court's warrant ~~recommending that the iOS device be examined for evidence identified by the warrant~~
